The purchased Ordinary Shares will be held by the Company in treasury. Following the purchase of these Ordinary Shares, the Company will have 39,976,272 Ordinary Shares in issue, including 656,793 shares held in treasury. The total number of Ordinary Shares held by the Company in treasury is 656,793, which attract no voting rights.

The total number of voting rights in the Company, excluding treasury shares as at 29 August 2025 is 39,319,479. This figure may be used by shareholders (and of with notification obligations) as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure and Transparency Rules.

Since the announcement of the Buyback Programme on 11th August 2025 AEP has purchased 74,943 Ordinary Shares in aggregate which are held in treasury.
